The Federal Trade Regulation rule for “Funeral Industry Practice” requires certain disclosures and prohibits misrepresentations. This Acknowledgement of Disclosure/Disclaimer form is a check list we ask those we serve to read and sign if during the arrangements for the above named deceased Twiford Funeral Homes did or did not do the following:

I/We, who made the arrangements for the cremation and/or final disposition of the Deceased, do hereby attest to the following:

1. I/We were given a General Price List effective on January 1, 2003 for my retention prior to discussing prices, services or merchandise.
2. I/We were shown a Merchandise Price List effective on January 1, 2003 prior to discussing prices of merchandise.
3. I We were told that certain goods and services may be furnished by a third party.
4. I/We were told that except in special cases, embalming is not required by law. I/We understand that embalming may be necessary, however, if I/We select certain funeral arrangements, such as a funeral with a viewing or use a rental casket in cremation. I/We understand that if I/We do not want embalming, I/We have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial.
5. I/We were not told that any law requires a casket for direct cremation or that a casket other than an unfinished wood box is required for direct cremation or for direct disposition.
6. I/We were told that state law does not require the purchase of an outer burial container or any of the goods and services I/We selected except as set forth on the Statement of Goods and Services Selected.
7. No claims were made to me/us as to the merchandise or other offerings of this by Twiford Funeral Homes (embalming, casket, outer burial container) as to the effect that embalming or the use of any merchandise available from this by Twiford Funeral Homes would delay the decomposition of the remains for a long term or indefinite time, or that any such merchandise would protect the body from grave site substances if such was not the case. No representations or warranties were made to me/us about the protective features of caskets or outer burial containers other than those made by the manufacturer. The only warranties, expressed or implied, granted in connection with goods sold with services we arranged were expressed written warranties, if any, extended by the manufacturer of such goods. No other warranties were extended to us by Twiford Funeral Homes.
8. I/We were not told that the amount of each of the cash advance items was the cost to the Twiford Funeral Homes except where such was the case. I/We were told that the Twiford Funeral Homes’ cost may be different based on volume or cash discounts or other professional trade customs where permitted by state or local law.
